### Background

It is vital that we manage the impact of COVID-19 on our children's education and emotional wellbeing. Many children, particularly those from disadvantaged backgrounds, or who are vulnerable in other ways, will have been adversely affected by extended time away from school. The majority of pupils have missed more than a full term in school, though supported and taught in various ways. It is likely that school closures will lead to the widening of gaps and slower rates of learning.

The catch-up premium is funded on a per pupil basis at £80 per pupil. This will be based on the previous year's census, meaning we will be in receipt of £20,640.

Strategies suggested by the Education Endowment Foundation (EEF) have been included in this plan.

### Intended outcome of Catch Up spending

This funding will be used for specific activities to support our pupils in catching up for lost teaching over the months of lockdown, in line with the curriculum expectations for the next academic year. The aim is to have our children working within their current year group curriculum, by the end of the summer term 2021.
